Hey Dennis,

I am happy to talk with you more about this and see if we can reach a solution on how to provide you what you are looking for while addressing my concerns. First, the request is for a detailed listing of not only PPE purchases, but requests for PPE from each entity, when those were filled, which ones were not filled, and those were sent back. Additionally, the request includes details noted on the lists of details about the entity. This would require a massive undertaking of staff time to provide. This comes at a time when we are still in the height of the pandemic response and KDEM staff time is extremely valuable. We will have to pull staff off of other tasks to pull this information and complete this analysis. Second, the requested information is sensitive operational and tactical information for the state during its emergency response. The ability to purchase PPE over the last 6 months has been severely limited due to competition with the federal government, other states, local units of government, hospitals, long-term care facilities, and many other private and public entities. Should this detailed list be released publicly, it would give the federal government and other states the complete list of all of the supplies we have used. Which could cause us further issues in attempting to purchase necessary supplies for the state. These supplies then are delivered to state and local partners, units of government and public and private entities. So, it greatly risks our efforts to provide PPE to those who need it across the state.

I am not sure I understand what question you are trying to answer with this request. If you can give me an idea of what you are after, I am more than happy to figure out a way to get you the information that answers your question(s) without jeopardizing the states response. Hope this makes sense and you understand where I am coming from. I am not trying to be difficult or be a barrier. However, I am trying to ensure that our staff at KDEM have what they need to continue to respond to the needs of those across the state.
